 - e. (b)\$1,000,000 Disease -Policy Limit (bodily injury by disease).
 - f. (c)\$1,000,000 Disease- Each Employee (bodily injury by disease).
 - g. Provide proof of coverage upon request
- 3. Commercial Auto Liability Insurance- Combined Single limit of \$1,000,000
 - h. List applicable entities as additional insured.
 - i. Including Hired & Non-Owned Liability coverage.
 - j. Provide proof of coverage upon request
