



Acord 25 Certificate of Liability Insurance (COI Acord) Policy

Wineries with an 02 or a 17/20 license who are participating in AVWA events **are required** to have the following in place in order to participate in any of our events:

1. One-time evergreen contract “**Insurance Requirements for Contractors/Vendors**”. We’ll request this contract from the primary contact of the winery member and store it on file. If there is a lapse in your membership with the Association, a new contract will be required.
2. **Certificate of Insurance (COI)**
 - a. The easiest is an annual listing that covers you for all association events during the coverage period.
 - b. Alternatively, you can provide a COI before each event for that event.

Required COI Language & Endorsements (per our Insurer):

To be dated for the policy year or for the date(s) of each event, depending on your execution. Provide this language to your insurer in issuance of your annual or event specific insurance. Policy should be TWO PAGES, so **ensure that your insurance agent provides the page two additional insured endorsement.**

ANNUAL POLICY TERM COI Language (preffered coverage by AVWA):
