



# A Message from Courtney DeGraff, Executive Director

## Anderson Valley Winegrowers Association December 1, 2025

Giving Tuesday is a moment to reflect on what binds us together as a community—and what we can do to strengthen that bond. The wine industry is, quietly, one of the most charitable industries in the country. Wineries donate wine, time, staff, and resources to support causes large and small, and most of that generosity is never formally tracked.

Since joining the Anderson Valley Winegrowers Association in 2019, I've had the privilege of seeing that spirit up close. Through our **2019-2025** festivals, auctions, and community initiatives, AVWA has helped raise **\$205,476 for local organizations**—including the Anderson Valley Health Center, Fire Department, Parent Teachers Associations, Mendocino County Resource District, Historical Museum, Skate Park, Housing Association, the Unity Club, and the Community Fairgrounds.

When I began, we had an old roll-up banner sign listing our cumulative contributions at roughly \$400,000. **Today, thanks to you, we've surpassed \$600,000 in charitable impact for Anderson Valley.**

In 2025, we expanded that commitment with the launch of our **AVWA Scholarship Program**, supported by American AgCredit and Atlas Vineyard Management. **We awarded \$7,000** in scholarships to students whose parents work in our local wine industry—the same families who help bring you wines with a story and a sense of place. With continued support from our partners and our White Wine Festival raffle, this program will only continue to grow.



As we look ahead, we see an opportunity to do even more for the community that sustains our vineyards, our businesses, and the pristine landscape we all cherish.

### Introducing the Anderson Valley Wines Community Action Fund

We're proud to announce the launch of the Anderson Valley Wines Community Action Fund, a **501(c)(3) charitable vehicle** established in partnership with the Community Foundation of Mendocino County.

This new fund creates a transparent, **tax-deductible way to give**—through cash or stock—with the sole purpose of supporting Anderson Valley nonprofits and student scholarships. Unlike raffle or auction donations, contributions to the Fund are fully tax-deductible and can be directed toward urgent or mission-focused needs year-round.
